

MANGROVE BIODIVERISTY PARK WAIVER AND RELEASE OF LIABILITY AGREEMENT

Disclaimer

This Consent and Waiver Agreement applies to all visitors, participants, ticket holders, and guests of the Mangrove Biodiversity Park ("the Park"). For purposes of this Agreement, the term "Park" includes all owners, directors, officers, employees, agents, representatives, volunteers, contractors, assigns, successors, and affiliates. The undersigned agrees that he/she is also signing this Release on behalf of the undersigned's minor children.

Express Assumption of Risk

By agreeing to this Consent and Waiver, the undersigned accepts that they are voluntarily visiting, entering, or participating in activities within the Park at their own risk. The undersigned assumes full responsibility for all risks of personal injury, accidents, illness, property damage, or loss, regardless of cause, including risks arising out of the negligence or fault of the Park, except in cases of gross negligence or intentional misconduct including but not limited to capsizing, sinking, or other hazards which result in wetness, injury, exposure to the elements, hypothermia, drowning, or death; attack by or encounter with insects, animals, or marine life forms;

Waiver and Release of Liability

By execution of this Release, the undersigned voluntarily releases, forever discharges, and agrees to indemnify and hold harmless Mangrove Biodiversity Park from any and all liability for any injury or damage sustained by the undersigned or any minor children under the undersigned's custody, care, and control, as a result of activities, programs, or use of equipment provided by Mangrove Biodiversity Park, regardless of cause. The undersigned assumes full responsibility for any such injuries or damages and further agrees that Mangrove Biodiversity Park shall not be liable for any loss or theft of personal property. The undersigned specifically agrees that Mangrove Biodiversity Park shall not be responsible for such injuries, damages, loss, or theft, even in the event of negligence or fault by Mangrove Biodiversity Park, whether such negligence is present now or arises in the future. This Waiver and Release does not apply to gross negligence or intentional torts by Mangrove Biodiversity Park.

Responsibility for Minors and Third Parties

The undersigned further agrees to indemnify and hold harmless the Park for all personal injuries, property damages, or other damages to third parties, including but not limited to other visitors or minors under the undersigned's custody, as a result of activities within the Park, even if such damages arise out of the negligence or fault of the Park. The Undersigned accept full responsibility for the safety, conduct, and supervision of minors under their care.



Acknowledgment of Consent

The undersigned states that they have had sufficient opportunity to review this Agreement, and fully understand its contents. They confirm that they have read this Consent and Waiver carefully, that they sign it voluntarily, and that they accept responsibility for themselves and for any minors under their care. The undersigned understands and agrees that signing this Consent and Waiver is a condition of entry into the Park, and that they are waiving any right to bring legal action against the Park for any negligence.
